

BOWER HILL SWIM CLUB MEMBERSHIP AGREEMENT

1. Membership:

A. Membership shall be granted on a family basis, that is to say, that a family membership shall entitle all members of the respective immediate family residing in the member's residence (adult members and their children) to all rights and privileges of a member in the Bower Hill Civic League Swim Club. A single membership is granted to one adult, age 20 years or older, only. A Teen membership consists of one member between the ages of 13 and 19 years old based on their birthday as of June 1st of the current year.

B. Payment of annual Seasonal Dues are required on or before the 1st day of March of the respective calendar year to maintain active membership in the club. The annual amount of dues shall be determined every January, by the Bower Hill Swim Club Officers and Directors. Current dues are \$550 per family, \$225 per single membership or \$175 per teen membership. Failure to pay the required dues by this date will result in a graduated fee assessed to the member as outlined on the dues invoice.

C. A one time bond purchase of \$450 and a \$50 application fee is required for all new members and is due at time of application to the Club. Single and Teen memberships do not require a bond purchase. Teen memberships due not require an application fee.

D. Failure to pay the Bower Hill Civic League Swim Club Seasonal Dues shall result in a suspension of use of the facilities and forfeiture of the bond, unless the member notifies the Board, in writing, prior to May 15th of the current season, that he/she no longer wishes to use the facility and is requesting their bond be placed on the For Sale List. Failure to provide written notice to the Board requesting sale of the member's bond will result in forfeiture of the bond which will then become the property of the Swim Club and available for sale to a new member.

E. While a former member's bond is on the For Sale List, the former member can rejoin the club at any time by paying the current season's dues. The bond will then be removed from the For Sale list.

2. Transfer of Membership:

A. Provided that membership in the club is less than 350 active members, inactive members whose bond has been assigned to the For Sale List, may transfer their bond to any new member by completing a Bond Transfer Agreement endorsed by both parties. The new member will then need to submit a completed application form, membership agreement and a check in the amount of the current season's dues for the transfer to be complete. Once all of this is received, the new member will be assigned the bond of the former member and the bond will be removed from the For Sale List and added to the active membership list.

B. In the event that there is at any time 350 members of the Bower Hill Civic League Swim Club, membership shall be closed to further applicants whose names shall be placed on a waiting list, and admitted to membership in the chronological order of their applications, as vacancies may occur from time to time. A \$50 application fee will be required to be placed on the waiting list.

3. Rules of Conduct:

All members of the Bower Hill Civic League Swim Club shall be bound by the rules and regulations governing the use of said pool as determined from time to time by the Board of Directors. Such rules regarding use, safety, and conduct at the pool shall be posted at the swimming pool. Violation of any of the rules shall be cause for suspension of privileges or expulsion from membership from the Bower Hill Civic League Swim Club. The Board of Directors shall have the power to review such violations and to determine the appropriate disciplinary action to be taken. In the event of expulsion or suspension of privileges, the Bower Hill Civic League Swim Club will not be responsible to refund any monies paid for the member's bond and/or yearly dues.

4. Management:

The operation and fiscal management of the Bower Hill Civic League Swim Club shall be vested in its Officers and Directors. Certain management functions may from time to time, be delegated to a committee appointed by the aforesaid Officers and Directors.

5. Title:

Title to the Swimming Pool, Civic League Building, Equipment and Accessories shall be vested in the Bower Hill Civic League. Use and operation of the pool and Civic League Building shall at all times be consistent with the Articles of Incorporation and by-laws of the Bower Hill Civic League.
