0	I have not experienced symptoms of fever, fatigue, difficulty in breathing, dry cough or any other symptoms relating to COVID-19 or any communicable disease within the last 14 days.
0	I have not, nor any member(s) of my household, traveled by sea or by air, internationally within the past 30 days.
0	I have not, nor any member(s) of my household, visited any area within the United States that was reported to be highly affected by COVID-19, in the last 30 days.
0	I have not been, nor any member(s) of my household, diagnosed to be infected of COVID-19 virus within the last 30 days.

Following the pronouncements above I hereby declare the following:	
O I recognize that I, in any case, may be at risk of contracting COVID-19.	
O With full knowledge of the risks involved, I hereby release, waive, discharge Bower Hill Swim Club, its board, officers, independent contractors, affiliates employees, representatives, successors, and assigns from any and all liabilit claims, demands, actions, and causes of action whatsoever, directly or indire arising out of or related to any loss, damage, injury, or death, that may be sustained by myself related to COVID-19 while participating in any activity while in, on, or around the premises of Bower Hill Swim club.	s, ties,
